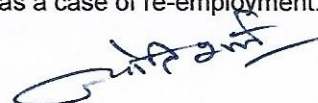

VACANCY NOTICE FOR THE POST OF CONSULTANT (ESTATE)

Applications are invited from employees retired from the post of Junior Engineer or above from CPWD/PWD/Railway/ NOIDA Authority etc. having B.E./B. Tech Degree/Diploma in Electrical Engineering, for engaging one Consultant (Estate) in Oil Industry Development Board (OIDB) on purely contract basis for providing assistance to Estate Division for carrying out the following job responsibilities:

- a. All Matters pertaining to day-to-day Operation and Maintenance of OI DB Bhawan including electrical/ electronic/ mechanical/ civil/ installations.
 - b. Preparation of all Notice inviting bids/tender/ quotation in respect of maintenance of OI DB Bhawan and submit the same through respective officials of OI DB.
 - c. To assist officials of OI DB in day-to-day monitoring/ supervision/ execution & implementation of various contract related to estate division of OI DB.
 - d. Scrutiny of invoices of various contractors working in OI DB as per the contractual provision and submit the same through respective officials of OI DB.
 - e. Submission of all statutory payments like lease rent/ ground rent/ electricity bill, water bills, internet facilities etc. in respect of OI DB Bhawan and OI DB's land at Dwarka.
 - f. To assist OI DB in the matter relating to its land at Dwarka, Delhi and to follow up the same with DDA or other authorities, etc.
 - g. To assist OI DB for obtaining various NOCs/permission from concerned authorities/department like Fire department, PESO, Noida Authority, PVVNL, U.P., UPPCB, etc.
 - h. Assist OI DB in the Estate Division's matters of Arbitration/ Court cases/ CAG Audit.
 - i. Any other work assigned from time to time.
2. Applicant should not be more than 64 years of age as on the last date of receipt of applications. The maximum period of contractual appointment as Consultant shall be upto selected applicant's attaining the age of 65 years.
3. The contractual appointment of Consultant shall be purely on contract basis for an initial period not exceeding one year which is extendable by another one year, subject to requirement of OI DB and satisfactory performance of the Consultant which shall be reviewed on yearly basis.
4. A fixed monthly amount of remuneration shall be admissible to the Consultant, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fix shall remain unchanged for the terms of the contract. There will be no annual increment/percentage increase during the contract period.
5. The Consultant so appointed may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement. No TA/DA will be paid for attending the interview.
6. The Consultant may be allowed leave at the rate of one (01) days for each completed month of consultancy service. Accumulation of leave beyond a calendar year may not be allowed.
7. His/her engagement as Consultant shall not be considered as a case of re-employment.



8. Tax Deduction at Source (TDS) as admissible shall be deducted from the monthly remuneration of Consultants.

9. Consultant so appointed may follow the normal working hours as prescribed [i.e. 09:00 AM to 05:30 PM], however, as per the exigency one has to sit late to complete the time bound work.

10. The appointment of Consultants would be on full-time basis and they would not be permitted to take up any other assignment during the period of Consultancy in the OI DB. The appointment of Consultants is of a temporary (non-official) nature against the specific jobs.

11. Consultant should maintain confidentiality of data & documents while consultancy period and after completion of contract. No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of his assignment or during the course of, assignment for the Department without the express written consent of the Department. The consultant shall be bound to hand-over the entire set of records of assignment to the Department before the expiry of the contract and before the final payment is released by the Department.

12. The Consultant appointed by OI DB shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the OI DB nor will he indulge in any activity outside the terms of the contractual assignment.

13. The Consultant will not be entitled for any benefit/compensation absorption/regularization of service with this organization.

3. Consultants will be carrying out the assigned works itself and submit the same to the concerned officials of OI DB.

14. The engagement of Consultants can be terminated by OI DB at any time without assigning any reason thereof by giving them one month notice. Termination shall be effected on the day right after the completion of one month of delivery of such notice. However, in case a Consultant wishes to resign, he will have to give one month advance notice or remuneration in lieu thereof before resigning from the engagement. OI DB may terminate the engagement in following conditions:

- a. The Consultant is unable to address the assigned work;
- b. Quality of the work is not to the satisfaction of the OI DB;
- c. The Consultant fails in timely achievement of the milestones as decided by the OI DB;
- d. The Consultant is found lacking in honesty and integrity.
- e. Requirement annulled by OI DB.

15. OI DB has the right to cancel the advertisement, and not go for engagement of Consultant, at any stage. It may accept or reject any or all applications, without giving any reasons therefore, whatsoever.

16. and about 50 of them are non-compliant. We have seized premises and imposed penalties on 15 such defaulters and action has been initiated against the other 35 establishments as well. They have been asked to obtain air and water consent to operate from UPPCB by December 31," said Vikas Mishra, regional officer, UPPCB.

The officials said the NGT had issued direction to this effect while hearing a petition filed by Ghaziabad residents Praseon Pant and Pradeep Dahalla in 2023, in which they contended that various hospitality establishments were operating without obtaining requisite consent under Water (Prevention and Control of

obtained consents shall not be allowed to operate," the tribunal said in its order on August 23.

The tribunal also said the UPPCB shall initiate punitive, preventive, prohibitive and remedial steps including assessment and recovery of environmental compensation from the proponents who fail to obtain NOCs within the stipulated time frame.

The tribunal also asked the pollution control board to submit a compliance report by January 15, 2025.

"In accordance with the orders of the tribunal, if erring establishments don't obtain NOCs in time, they will be liable to pay fines and also face seizure of premises," Mishra said.
