1. 1. Service & Support

3. Forms of EMD and PBG

OIDB SCOPE OF WORK: Providing of 3 Nos. of Chauffer Driven Car(s) (1 vehicle Sedan, 1 vehicle Premium Sedan & 1 vehicle SUV) on monthly basis for OIDB office, Sector-73, NOIDA. The contractor will ensure that the car provided is of 2023 onward model in good condition with spare wheel, and proper tools and fire extinguisher. Car should be equipped Modern Car Music System, Mobile Charger, Sanitizer, Mask, Perfume etc. The bidder shall deploy its owned Vehicles at OIDB and the vehicles should have Delhi/Noida registration.

Buyer Added text based ATC clauses

- i. The Bidders should upload an Index in first page indicating page number of all requisite certificates / documents. Bids without index may be disqualified and will not be considered further.
- ii. The bidder should submit copies of the RCs, Insurance, Permits, etc of the vehicles (Sedan, Premium Sedan & SUV) deployed in the Ministry/Autonomous Bodies, along with the bid documents.
- iii. Initially the service contract will be awarded for two years. However, the Contract may be extended further 2 years on yearly basis, beyond the initial contract duration (subject to satisfactory performance and mutual consent).
- iv. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent at the time of placement of contract. - vi. Option of Fuel Type, selected in the Bid Specifications will be "ANY". The service provider has the choice to provide either Petrol or CNG Vehicle - provided that, if a CNG Vehicle is being supplied, then the CNG Kit in the vehicle must be Company fitted only, duly endorsed in RC of the vehicle.
- vii. The OIDB can hire extra Premium Sedan vehicle (up to 10) above the contract

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

12. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
