OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

Eligibility Criteria: The eligibility criteria for the bidders are as follows:

i). The bidder must possess a valid OEM authorized service provider certificate issued by M/s Xerox India Ltd. **A copy of the certificate along with supporting communication from M/s Xerox India Ltd. in this regard must be submitted with the bid.**

ii). The bidder must have an office located in Noida or Delhi. **As proof, the bidder shall submit a copy of the GST Registration Certificate & Company/Firm Registration Certificate issued by the concerned authority along with the bid.**

iii). The bidder must have at least three last years experience ending 31st March, 2025 in providing after-sales service/maintenance of Multifunction Photocopier Machine to Central/State Government Ministries/Departments/PSUs/ Autonomous Bodies located in Delhi/NCR. **Copies of relevant FSMA/ CSMA/ Work Orders must be submitted with the bid** (Single/ Two/ Three Completed work order value as indicated above should be exclusive of GST):

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
